



Dear friend.





But the entire history of Indigenous Australia since colonisation is a story of our survival against incredible odds.

So I ask you not to be disheartened. Today's negative government policies are not the end of the story!

There are many positive initiatives at the local and regional levels which are flourishing in spite of Government indifference. Indigenous and non-Indigenous Australians are steadily working together, nurturing and building on the many achievements:

- A culture of agreement-making is developing over a wide range of matters critical to the lives of Indigenous Australians – health, service delivery, employment, criminal justice issues, native title – the list is long.
- The national, state and territory ANTaRs and many smaller community groups across Australia are always active, making detailed submissions to recent Senate Committee Inquiries into the stalling of the reconciliation process and the Government proposals to greatly weaken the Human Rights Commission.
- ANTaR is supporting youth initiatives, such as the ReconciliACTION Network, a leading force for the future of Indigenous social justice.
- ANTaR has begun work with Indigenous leaders and the Fred Hollows Foundation to develop a strong campaign addressing the appaling health and living conditions of many Indigenous Australians.
- · And ANTaR continues to fight tirelessly on on-going issues such as a just reconciliation and native title.

Indigenous people take great heart from knowing that we do not stand alone.

Through the campaign for direct negotiations, ANTaR is also joining with us in fighting back against the Federal Government's ongoing attacks against Indigenous self-determination.

There is no right more fundamental for Indigenous people than that of self-determination.

Self-determination is the right of Indigenous people to take responsibility for policy and other decisions which affect our lives. It is about Indigenous-led solutions and about creating strong communities that can overcome disadvantage. It is also a right Indigenous people possess under United Nations instruments to which Australia has committed itself.

Successive federal governments have only ever conceded a very limited form of self-determination, through an ATSIC structure starved of both funds and responsibility.

And now, the Federal Government wants to abandon even that small concession.

Once again the Federal Government is leading us backwards - back to the assimilationist policies of half a century ago.

Government policies which preclude self-determination can only be destructive to Indigenous communities. As Noel Pearson recently explained,

"government must relinquish responsibility in order for there to be a restoration of responsibility in (Indigenous) society."
